The Real Estate (Regulation & Development) Act, 2016 passed by the Parliament which aims to introduce governance in the Real Estate Sector came into force on <u>01.05.2016</u>. As per the provisions in the said Act, the State Government is required to establish a 'Real Estate Regulatory Authority'.

As part of establishing the said Authority, Government have to appoint a Chairperson and 2 whole time members.

Applications are invited from individuals / State or Central Government Employees / suitable candidates to be appointed as Chairperson and Members of the Real Estate Regulatory Authority. The applicants who fulfill the following criteria shall apply.
